## INSTRUCTION TO THE CANDIDATES

- 1. No separate Admit Card will be issued. A self-attested photocopy of the valid photo identification proof (For example: Passport, Voter ID and Aadhaar Card) must be submitted for verification of candidature along with the original (not photocopy or scanned copy).
- 2. Candidates will be permitted to appear for the examination ONLY after verification of their credentials by the centre officials.
- 3. To facilitate the verification of their identity, candidates must report at the examination venue at least 30 minutes before the scheduled commencement of the examination.
- 4. Candidates will be permitted to occupy their seats 30 minutes before the scheduled start of the examination.
